Rules & Regulations

1. Parents/guardians and students are requested to submit this form within three days of its issuance. Please read all the points carefully and provide your consent with the signatures of both the parents/guardians and the student.
2. Students must maintain a high level of discipline at all times.
3. The prescribed dress code must be strictly followed at all times.
4. Students are required to maintain proper grooming, including cleanliness, tidy hair, trimmed nails, a proper uniform, and an overall presentable appearance, at all times.
5. Every student must carry their ID card and present it whenever required.
6. Students arriving late to class or laboratory sessions will be marked absent for the day.
7. Students are not permitted to leave the school premises during study hours.
8. A minimum of 90% attendance is required to be eligible for the final examination conducted by NEB.
9. Students who are absent due to valid reasons must submit a written application signed by their parents/guardians. A doctor's prescription must also be attached if the absence is due to illness.
10. Prior written permission must be obtained from the administration for any leave.
11. Classes will not be suspended without prior notice from the administration, except under unavoidable circumstances.
12. Any misuse or mishandling of school property will result in penalties, including fines and/or replacement costs.
13. Library rules must be followed. Books should be returned on time and in good condition.
14. Computer laboratory rules must be followed. Students are strictly prohibited from playing games or accessing prohibited or unrelated websites during lab sessions.
